

SÉLITE INT'L is a Spanish company which from 1993 have been giving relocation and legalization services to expatriates.






### WHAT WE GET?

### ORDER OF PROCEEDINGS PRIOR TO ARRIVAL

- Request a copy of your passport.

  - Ask for documentation to business application form Work Permit.
  - Application to the labor authority for the permit to work.
  - Advice, monitoring and support of visas.
- Pre-arranged all the services you need on arrival.



# ORDER OF ACTIONS DURING THE EXPLORATORY TRIP

- Welcome at the airport and back to the hotel.
- Tour guidance on possible areas of permanent residence.
- Visits to potential houses.
- Opening of bank accounts for non-residents.
- Application for Certificate of Residence Community (NIE).



### ORDER OF ACTIONS FROM THE FINAL ARRIVAL

- Delivery of temporary housing.
- Making one or more routes (depending on needs) until the expatriate choose his/her new home.
- Formalization of the contract including utilities.
- Finish the contract for temporary house.
- City Council Registration.
- No Community: application for residence cards (employee/family).
- Application of medical cards (employee/family).
- Residence bank account.
- Any other service required for integration (employee/family).



### ORDER OF ACTIONS DURING THE STAY

- Renewal of permits, cards or certificates.
- Any other legal service as return permits (when residence cards are expired or in renewal process) or documents certification for other countries.
- Continued service (our lines of communication are always open during your stay in Spain for any situation which could arise).
- Foreign visas.





## ORDER OF ACTIONS AT THE END OF THE STAY



- We communicate to public institutions the end of the stay in Spain.
- Check the house.
- Deposit management.
- Disconnection of utilities and cancellation of services.
- Closing bank accounts.
- Withdrawal from registration in civil registry.
- When necessary, management of the required documentation for the future destination (visas, certifications, reports, document certification, etc.).
